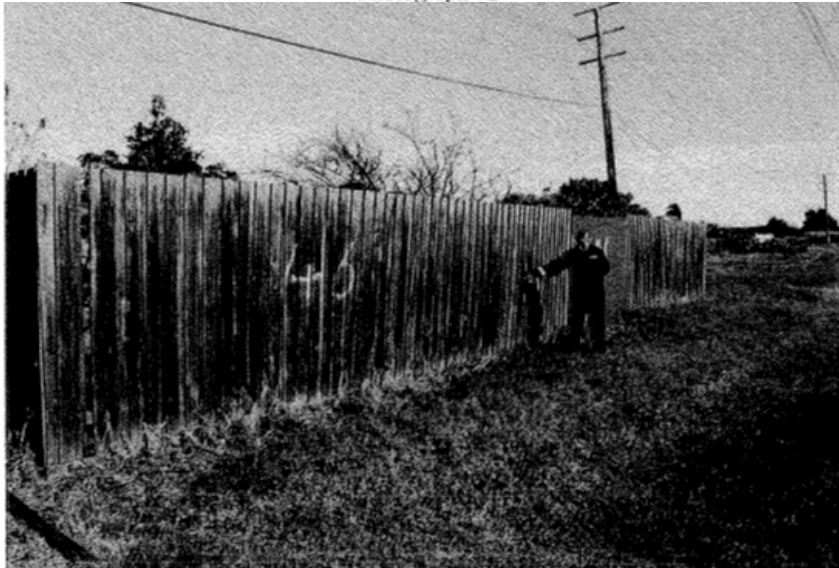

His Honour: Page 38 L21 Yes.

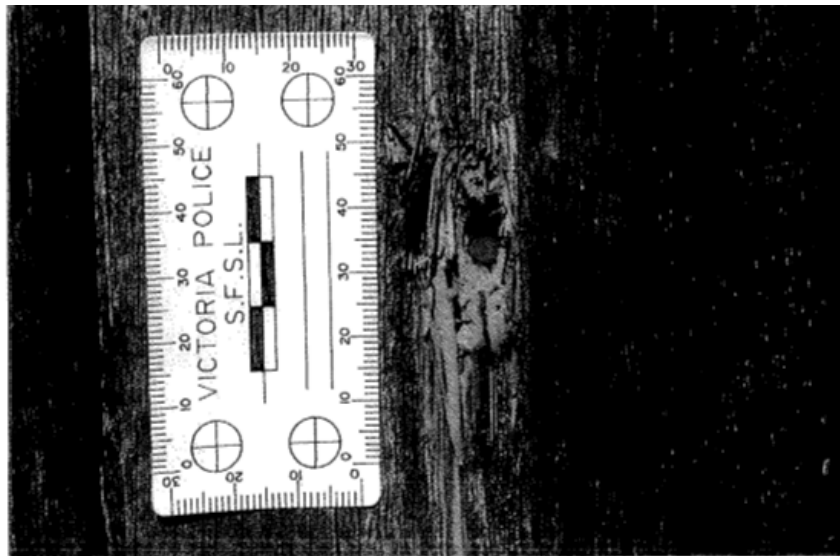
Mr Chatwick: Page 38 L22 -24 .And then 86 is around that corner, so it's actually on that – It's gone through that fence.
